New York, NY – September 6, 2013 –*The Wall Street Journal* recognized the Frank Value Fund as a “Category King.” Ranking 2nd out of 817 funds for YTD performance ended August 31, 2013. The Frank Value Fund also boasts a five-year record in the top 7% of its Lipper Category, Multi-cap Core. This is the seventh time in the Frank Value Fund’s history that it has been recognized.

“August marked the biggest decline in the S&P 500 so far in 2013” states Brian Frank, portfolio manager. “Our intense focus on the downside resulted in the Frank Value Fund’s tenth straight month of outperformance.”
